A BILL

To require the Assistant Secretary of Commerce for Communications and Information to establish an interagency strike force to increase prioritization by the Department of Interior and Department of Agriculture by senior management of the Department of Interior and Department of Agriculture, or an organizational unit of reviews for communications use authorizations.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Expediting Federal
3 Broadband Deployment Reviews Act”.

4 **SEC. 2. STRIKE FORCE.**

5 (a) DEFINITIONS.—In this section:

6 (1) APPROPRIATE COMMITTEES OF CON-
7 GRESS.—The term “appropriate committees of Con-
8 gress” means—

9 (A) the Committee on Energy and Com-
10 merce of the House of Representatives;

11 (B) the Committee on Natural Resources
12 of the House of Representatives;

13 (C) the Committee on Commerce, Science,
14 and Transportation of the Senate; and

15 (D) the Committee on Environment and
16 Public Works of the Senate.

17 (2) ASSISTANT SECRETARY.—The term “Assist-
18 ant Secretary” means the Assistant Secretary of
19 Commerce for Communications and Information.

20 (3) COMMUNICATIONS FACILITY.—The term
21 “communications facility” includes—

22 (A) any infrastructure, including any
23 transmitting device, tower, or support structure,
24 and any equipment, switches, wiring, cabling,
25 power sources, shelters, or cabinets, associated
26 with the licensed or permitted unlicensed wire-

1 less or wireline transmission of writings, signs,
2 signals, data, images, pictures, and sounds of
3 all kinds; and

4 (B) any antenna or apparatus that—

5 (I) is designed for the purpose of
6 emitting radio frequency;

7 (ii) is designed to be operated, or is
8 operating, from a fixed location pursuant
9 to authorization by the Commission or is
10 using duly authorized devices that do not
11 require individual licenses; and

12 (iii) is added to a tower, building, or
13 other structure.

14 (4) COMMUNICATIONS USE.—The term “com-
15 munications use” means the placement and oper-
16 ation of a communications facility.

17 (5) COMMUNICATIONS USE AUTHORIZATION.—
18 The term “communications use authorization”
19 means an easement, right-of-way, lease, license, or
20 other authorization to locate or modify a commu-
21 nications facility on covered land by the Department
22 concerned for the primary purpose of authorizing
23 the occupancy and use of the covered land for com-
24 munications use.

1 (6) COVERED LAND.—The term “covered land”
2 means land managed by a Federal land management
3 agency.

4 (7) DEPARTMENT CONCERNED.—The term
5 “Department concerned” means the Department of
6 the Interior or the Department of Agriculture.

7 (8) FEDERAL LAND MANAGEMENT AGENCY.—
8 The term “Federal land management agency”
9 means—

- 10 (A) the Forest Service;
11 (B) the Bureau of Land Management;
12 (C) the National Park Service;
13 (D) the Fish and Wildlife Service; and
14 (E) the Bureau of Reclamation.

15 (9) ORGANIZATIONAL UNIT.—The term “orga-
16 nizational unit” means—

17 (A) with respect to public land adminis-
18 tered by the Secretary of the Interior—

- 19 (I) a State office;
20 (ii) a district office; or
21 (iii) a field office; and
22 (B) within the Forest Service—
23 (I) a regional office;
24 (ii) the headquarters;
25 (iii) a management unit; or

1 (iv) a ranger district office.

2 (10) STRIKE FORCE.—The term “Strike Force”
3 means the interagency strike force established in
4 subsection (b)(1).

5 (b) STRIKE FORCE.—

6 (1) ESTABLISHMENT.—Not later than 180 days
7 after the date of enactment of this Act, the Assist-
8 ant Secretary shall establish an interagency strike
9 force to increase prioritization by the Department
10 concerned, senior management of the Department
11 concerned, or an organizational unit of reviews for
12 communications use authorizations.

13 (2) DUTIES.—In carrying out the prioritization
14 under paragraph (1), the Strike Force shall—

15 (A) conduct periodic calls between mem-
16 bers of the Strike Force relating to requests for
17 communications use authorizations; and

18 (B) monitor and facilitate accountability of
19 the Department concerned and organizational
20 units to meet objective and reasonable goals for
21 the review of requests for communications use
22 authorizations.

23 (3) MEMBERS.—The Strike Force shall be com-
24 posed of such representatives of Departments con-

1 cerned as the Assistant Secretary considers appro-
2 priate, in addition to—

3 (A) the Assistant Secretary;

4 (B) a representative of the Department
5 concerned;

6 (C) senior management of the Department
7 concerned; and

8 (D) the head of each organizational unit.

9 (4) REPORT TO CONGRESS.—Not later than
10 270 days after the date of enactment of this Act, the
11 Assistant Secretary shall submit to the appropriate
12 committees of Congress a report on the effectiveness
13 of the Strike Force in increasing the prioritization of
14 reviews for communications use authorization re-
15 quests.
